Their appearance should be a mid to pale yellow colour and be evenly coated in cream powder and should not look greasy or translucent. The crisps should taste of potato crisps with salt and vinegar flavour. The crisps will have a slight odour of sunflower oil. There should be a minimal amount of crushed crisps in the bag.

	Potatoes, high-oleic sunflower oil, sherry vinegar powder, sea salt, Two Farmers cider vinegar powder, sugar, acid: citric acid, rice flour, natural flavouring, antioxidant: rosemary extract.
