Aroma: Milk chocolate / cocoa aroma with roasted peanut to follow. No off notes

Flavour: Milk chocolate / cocoa flavour with peanut and oat to follow. Overall chocolatey flavour with no off notes.

Texture: Soft date layer, moist, followed by firm oat base with slight crunch from soy crispies and roasted nuts. Not dry, also, not soft melty chewy

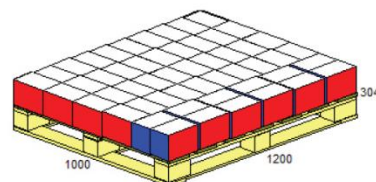
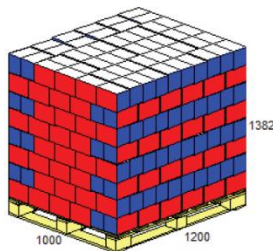
