Feverfew contains Sesquiterpene lactones - these include parthenolide (the most pharmacologically active),

chrysartemin A and B and santamarin. Parthenolide in particular has been shown in research to inhibit prostaglandin production which results in the reduction of inflammation, decreased histamine secretion, decreased activation of inflammatory cells and fever reduction (hence the name).

The inhibition of prostaglandins and decreased histamine secretion is probably the reason why feverfew is beneficial to many migraine sufferers because this will reduce the spasms of the blood vessels that are believed to cause the pain.
