



8. Process Information

Ingredients are picked according to plan ready for processing, one blend is 552kg. The processing involves a fruit breaker and inspection tables where ingredients are hand-graded, and placing flakes on the incline belts, the product is then transferred via belts into IBCs. The IBC is blended for a set amount of time to ensure thorough mix. The IBC is then placed over a multi-head weigh pans which fill into bags using a vertical form fill box machine, is put through a box and case packer. These are then coded and palletised.
