Thoroughly wash out and disinfect your current refillable roll-on bottle. Allow to dry. Shake the refill pouch thoroughly, then pour into the dry bottle until nearly full.

We recommend you pour over a sink as the product contains salt which may mark some household surfaces. Screw on the roll-on head until tight.
