All the ingredients in this formulation and the product itself are non-GM, and non-irradiated.



The above product has been manufactured according to GMP guidelines. Our purchasing specification for individual ingredients states that these are to comply with all relevant EU regulations in relation to food supplements, which includes the regulation on PAHs 2015/1993, heavy metals and micros, and that the ingredients are to be Non-GM and Non-Irradiated. Supplier's statements, risk assessments and CofAs are checked and kept on file, G&G also does their own due diligence tests on raw materials to assure the quality and compliance to EU regulations.

Based on the above we confirm that this product is per current EU regulations on Microbacteria levels, Heavy Metals and PAH's for food supplements. Lead NMT 3ppm, Cadmium NMT 1ppm, Mercury NMT 0.1ppm.

The manufacturing facility (Clean Room) at G&G Food Supplies Ltd is validated as EU GMP Grade D (ISO Class 8). Company registration number 2103924. G&G are inspected and certified by the MHRA for EU GMP, SGS for a third party Food Safety Certificate, the Soil Association as organic, Rabbi Adler for Kosher, and the World Halal Trust for Halal. G&G are members of the UK Health Food Manufactures Association and are registered for manufacturing food products with the local council.
